

Checked baggage charges – FlyEasy Fare Family

FlyEasy fares include only one piece of hand baggage up to 8 kg free of charge.

Passengers have a **possibility to pay for first checked bag up to 23kg and 158 cm**. If that first piece is bigger or heavy or bigger and heavy, it will be considered as excess baggage and charged according to excess baggage policy. The same applies to every additional piece (second extra piece and every other).

Charges for first and second and every other extra checked bag are specified for domestic and international flights as per table below.

Infants with FlyEasy fare family cannot buy a first extra bag.

All charges are specified **per direction**:
