

FORMAL STATEMENT TO THE PURPOSE OF ENTRY IN ITALY

In order to counter the intensification of the emergency due to COVID-19 epidemic, the Decrees of the Minister of Infrastructure and Transport implemented together with the Minister of Health, on March 17 2020, n. 120 and March 18, 2020, n. 122, extended until April 3 with the Decree n. 127 of the Minister of Infrastructure and Transport implemented together with the Minister of Health, on March 24 2020, has established that:

- all natural persons entering Italy, by air, rail, sea and road transportation, even if asymptomatic, are obliged to immediately communicate their entry in Italy to the Department of prevention at the competent local health unit (ASL), and are subject to health surveillance and fiduciary isolation for a period of fourteen (14) days. In case of COVID-19 symptoms onset, it is mandatory to report this situation immediately to the Health Authority through the pertinent telephone numbers;
- in derogation from the provisions of the previous point, exclusively for proven working needs and for a time not exceeding 72 hours - unless a justified extension for specific needs of an additional 48 hours - natural persons entering Italy, by air, rail maritime and road transportation, are required to submit a formal statement, pursuant to Law art. 46, 47 Decree of the President of the Republic December 28, 2000, n. 445, in which they declare that enter in Italy is only due to working necessities. With this declaration, it is also assumed the obligation, in the event of COVID-19 symptoms' onset, to report this situation immediately to the Department of prevention at the competent local health unit (ASL) through the pertinent telephone numbers and self-isolate, while health authorities are taking actions for the specific case;
- The aforementioned provisions do not apply:
 - a) to healthcare personnel entering Italy for the practice of professional healthcare qualifications, including the temporary practice pursuant to Law art. 13 D.L. 17.03.2020, n. 18;
 - b) to cross-border workers entering and leaving the national territory for proven work reasons and the consequent return to their own dwell, house or residence, in compliance with the provisions of Law art. 1, l. a) DPCM 8.03.2020, extended within the national territory by the Law DPCM 9.03.2020 further modified by DPCM 22.03.2020;
 - c) crew and travel staff, members of companies with legal seat in Italy, in accordance with the provisions of the Law, Decree n. 127 art.1, c.2 of the Minister of Infrastructure and Transport implemented together with the Minister of Health, implemented on March 24, 2020
